Senior Scholarship highlights - see summary from Terry below; financial need component suggested; staff input/ranking recommended as attachment to application, mention/promote scholarship application process/dates during foundations; included 1-2 year accredited schools, as well as 4 year - trade, tech or university; number of scholarships and/or amount dependent on fundraising efforts for the year; portfolio should impact decision more than GPA or ranking - GPA/class ranking not as critical

## Terry's notes:

- The scholarship should be named the "Barry O'Connor Scholarship" at least for the next three years. After that the name could be changed or remain the same at the discretion of the board at that time.
- February 15<sup>th</sup> would open the scholarship applications period. There should be a six week time span during which the applications would be accepted. Applications would be turned in by April 30<sup>th</sup>.
- There would be a minimum of 4 board members reviewing applications. Board members would review with staff input.
- There would be two options for a scholarship. One scholarship in the amount of \$250 would be awarded to
  a student attending a two year accredited school (example: Fox Valley Tech, UW Menasha), and a \$500
  scholarship awarded to a student attending a 4 year accredited school (example: UW Oshkosh, Lawrence
  University).
- Depending on the amount of scholarship money available there would be one \$500/\$250 scholarship awarded (\$750) or two \$500/\$250 (\$1500) scholarships awarded. Our group thought it would be nice to have four scholarships awarded.
- Scholarship criteria would include a resume, a short essay (no longer than on page), GPA in the top 50% of class. An emphasis on "need" would be included. There would be no letter of recommendation needed.
- Award winners (including past winners) would be listed on the website and promoted in Appleton North
  publications. In addition we would create an area within the school to put up a picture, name, and year of
  graduation of award winners.
- This is the information from my notes. Perhaps Mary and Mark can add their thoughts. I did talk to Barry about our thoughts on naming the scholarship after him for the first 3 years (and then ??) and he was fine with that.
