• Staff Reports

Budget (Patrick) – 501c3 increased by \$382.27; thank you to ACA student, Erika, for coordinating face painting at Freight Night – earned \$350 for ACA, which was deposited in the 501c3 acct; \$32.27 was earned from United Community (suggestion to send postcard in November with a reminder to use goodsearch/goodshop for holiday shopping); also notate AmazonSmile to ACA parents – an additional way for ACA to earn \$ on purchases; additional \$3300 was added to the district accounts from the ELA curriculum buyout (last payment); curriculum-related expenditures were \$172.45 for books; staff in-service for standards based grading conference was \$372.79; LGL donor base expense was \$222.30 and website expense was \$10

ACA Enrollment Report (Lori) – 113 current – 120 max; 2 successful shadow days (15 plus 19 students); application are at 10, which is good; 2 students joining at semester possibly; Renee will be attending scheduling days at the other Appleton high schools

Staff Report (Renee) – staff attended conference regarding Standards-Based grading (grade should reflect student learning only) – excellent conference given by expert in the field; currently implementing in ACA (ACA will be the "pilot" for the district) – group of teachers who attended from AASD and will continually meet throughout the year; 3rd round of seminars; portfolio and project presentations to wrap up at the end of the semester (foundations); February is main month for enrollment, but still movement after that with no formal deadline
