- <u>Agenda Changes-Calendar Updates</u> Board Annual Planning Meeting/Retreat now rescheduled for June 15th possibly, Renee will check with staff and date will be confirmed at our next meeting
- <u>ACA Enrollment Report</u> 36 incoming freshmen, 44 applied 8 are upper classmen (2 seniors coming for senior capstone experience), enrollment time is closed, 3 separate emails to new students updating info and sharing info about Rally Day, only 2 refused ACA enrollment so far from confirmation emails Lori has sent, about 3 total from out of district, 106-112 total, 2.8 allotted FTE decreased as a result of budget cuts from the state

Mailing to 8th graders on hold - numbers are good, marketing to parochial is possibly another avenue to pursue next year – smaller learning community, maybe next year as we establish marketing vision/focus and tie in new website, Explore Night and Career Fair had impact, testimonials need to be used in marketing and website
